ARTICLES OF INCORPORATION
OF
GODWIN SALES, INC.

ARTICLE I.

The name of this corporation is: GODWIN SALES, INC.



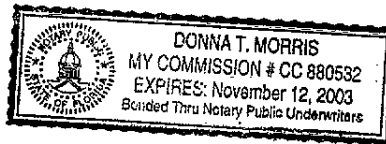
