ARTICLES OF INCORPORATION OF THE SMILE STORE, INC.

EFFECTIVE DATE

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is THE SMILE STORE, INC. and the principal place of business shall be 5193 Whitehurst

Lane, Crestview, FL 32536.

DURATION: The corporation shall exist perpetually.

ARTICLE III.
