ARTICLE I

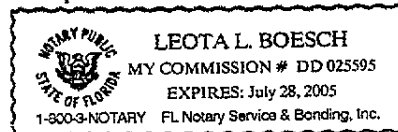




