When we became aware that the corporate annual report and its corresponding fee of \$150 was not filed by the May 1 due date, we immediately went online and downloaded the proper form. However, we must have misunderstood the online site as we read it to say that if we sent in this form with the \$150, we would not be charged the penalty for late filing? Our homes and our business are located in Punta Gorda, Fl, home of landfall of Category 4 Hurricane Charley on Friday the 13<sup>th</sup> of August, 2004, as well as indirect hits by Hurricanes Frances, Ivan and Jean in the immediate following weeks, so we have been trying to put lives and businesses back together ever since.

We respectfully request that the original payment already received of \$150 be accepted as payment in full and that the corporation not be assessed the late fee of \$400 for filing after May 1, 2005. We ask for this abatement of the late filing penalty because of the extenuating circumstances surrounding the late filing and the fact that there was no intent on the part of the corporation or its shareholder to avoid paying the annual fee. We apologize for this oversight and hope that you agree that we have been punished enough in Charlotte county and that the late filing penalty should be waived due to the circumstances.
