#### ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of this Corporation is Arctic Breeze Fog and Mist Systems, Inc.

## ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.
