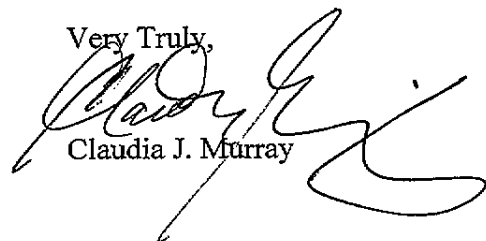

**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be: **DISPUTE MEDIATION ASSISTANCE, INC.**

**ARTICLE III**

**PURPOSE**

This corporation is organized exclusively for the purpose of providing Dispute Mediation services within the disciplines of Dispute Resolution/Mediation. In addition, the corporation is organized to provide consulting services for legal research, legal secretarial, drafting of legal documents, and general law office assistance under the supervision of a licensed practitioner.

Notwithstanding the above, Dispute Mediation Assistance, Inc. shall engage in the general activities of:

A. Investing the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investments, and to own real and personal property necessary for the rendering of services of the business.

B. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objectives of this corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this corporation; and in general, either alone or in association with other corporations, firms, individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or

objects of this corporation.

B. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by the laws of the United States and the State of Florida.

#### **ARTICLE IV**

The maximum number of shares this corporation is authorized to issue is 100, par value \$10.00 per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

#### **ARTICLE V**

##### **DURATION**

The duration of the corporation existence shall be perpetual.

#### **ARTICLE VI**

##### **MEMBERSHIP/BOARD OF DIRECTORS**

The corporation shall have one or more classes of members, as provided in the corporation's bylaws. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

The number of Directors constituting the first Board of Directors is 1, name and address being as follows:

Officers, or Directors be subject to the payment of the debts or obligations of this corporation.

**ARTICLE VIII**

**DISSOLUTION**

At the time of dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, dispose of all of the assets of the corporation.

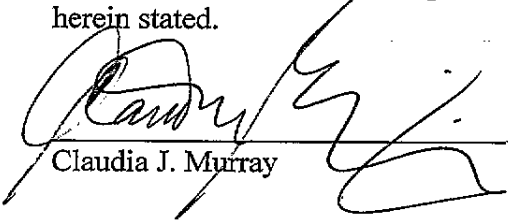

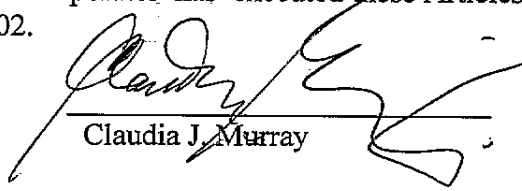

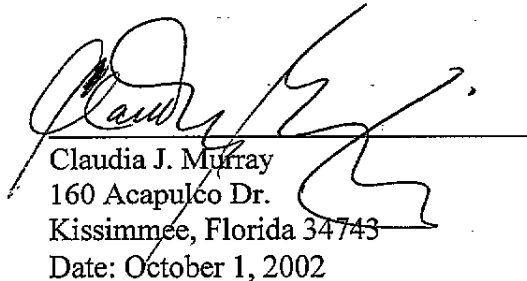
