

ARTICLES OF INCORPORATION

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I, NAME

The name of the corporation shall be: Zericks, Inc.

ARTICLE II, PURPOSE

First: This corporation is organized for the purpose of providing software engineering services and software development and other computer consulting services.

Second: The foregoing purposes and activities will be interpreted as examples only and not limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purpose which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.

Third: The corporation is organized to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.

The date of incorporation shall be the date the Florida Department of State, Division of Corporations certifies and files these Article of Incorporation.


ARTICLE VIII. BYLAWS

The corporation bylaws shall establish:


1. Provisions concerning management and regulations of the affairs of the corporation.
