**ARTICLES OF INCORPORATION**  
**OF**

The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:


- FIRST:** The name of the Corporation is SPAPLEX CORP. (the "Corporation").

- THIRD:** The Corporation is authorized to issue 20,000,000 shares of common stock, par value \$.001 per share.

- TENTH:** The corporate existence of the Corporation shall commence on upon the filing of the Articles of Incorporation with the State of Florida.


