ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

Article I

The name of the corporation shall be: Conquest Solutions, Inc.

Article II

The principal place of business for Conquest Solutions, Inc. shall be at:

Article III

The purpose for which Conquest Solutions, Inc. is organized is for the sales, import, export, and assembly of computer parts. Assembled computers and parts will be sold to businesses, schools and personal clients on a global scale via the Internet and direct marketing through the computer department. A certified copy of these articles of incorporation will be used to purchase parts at wholesale cost---which in turn will be assembled and sold at a price that includes labor, shipping and handling. Conquest Solutions, Inc. will also provide services in technical support, computer upgrading and networking.

Article IV

The number of shares of stock will be three for now. However shares of stock for Conquest Solutions, Inc. may be sold with certificates at a later date once the corporation's level of gross profit increases to a point beyond that of all business expenses and tax liabilities. Should such shares of stock be sold at a later date, amendments and bylaws will be added to these articles of incorporation for Conquest Solutions, Inc. by its three initial officers.

Article VI

All decisions affecting Conquest Solutions, Inc. either directly or indirectly, including but not limited to financial transactions, purchases, sales, expansion, advertising and networking, shall be made by all three initial officers present, or with the expressed written consent of an officer not physically present at the time and place where the decision was initially made. All three signatures and dates of signatures of the initial officers must be present on any and all documentation concerning decisions affecting Conquest Solutions, Inc., or the documentation may be attached with the expressed written consent of an officer not physically present, in order to validate its existence. All business decisions affecting Conquest Solutions, Inc. will be made by a unanimous vote--majority rules (two officers out of an initial three), with the exception of the termination of employment of an initial officer. Termination of employment of an initial officer by any and all means is absolutely non-existent. An initial officer may only resign from his position---and only with his expressed written consent.

Article VII

All profit of Conquest Solutions, Inc. will only be divided among its three initial officers with a pay rate as follows: the President of Operations, Sales & Technical Support will earn 45% of all profit; the President of Import & Export will earn 45% of all profit; and the President of Marketing will earn 10% of all profit. Allocation of profit earned and amount of executive officers is subject to change through majority vote of the three initial officers. Should such changes occur at a later date, amendments and bylaws will be added to these articles of incorporation for Conquest Solutions, Inc. by its three initial officers. "Profit" will be defined as currency left over after all business expenses (including payment on loans and to investors) and tax liabilities are fulfilled. Any and all financial transactions must be made through the primary business bank account of Conquest Solutions, Inc. or must be immediately deposited into such primary business bank account. "Immediately" will be defined as 7 days.

Article VIII

Any additions, changes or deletions of amendments or bylaws from these articles of incorporation may only be done by its three primary executive officers which are the President of Operations, Sales & Technical Support, President of Import & Export, and President of Marketing, regardless of any addition of officers.
