Article IX - Indemnification

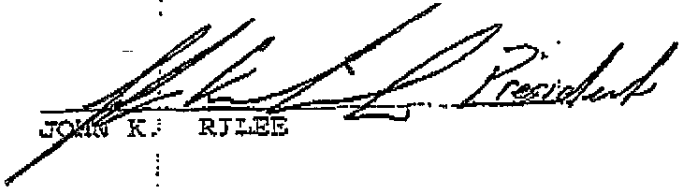

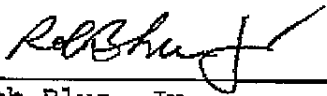
