The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

# NAME

#### ARTICLE II

# DURATION

The duration of the corporation is perpetual.

## ARTICLE III

# PURPOSE
