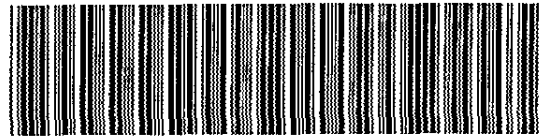


Re: Articles of Dissolution
