**ARTICLE I - NAME**

The name of this corporation is Locate Group, Inc.

**ARTICLE II - PURPOSE**

This corporation is organized for the purpose of activities involving sales of locating equipment for auto and personal use.

## **ARTICLE IX - AMENDMENT**

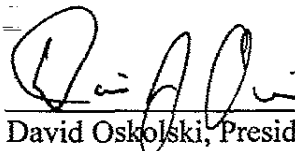

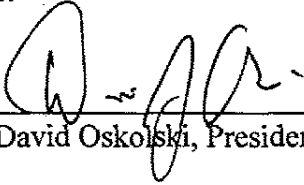
