ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is S.R. Airspares, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

ARTICLE X - AMENDMENT


