**ARTICLES OF INCORPORATION
OF
THE VIDEO PRECEDENT, INC.**

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name shall be **THE VIDEO PRECEDENT, INC.**

**ARTICLE II
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III
PURPOSE**

The purposes of the corporation are:

- (a) To engage in business in the legal videography industry, without limitation, the creation, production, marketing and distribution of legal video products and services.
- (b) To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue, is twelve thousand (12,000) shares, all of which shall be common shares with a par value of one cent (\$0.01).

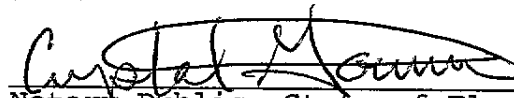
