THANK YOU FOR YOUR CONSIDERATION AND I AWAIT YOUR RESPONSE.

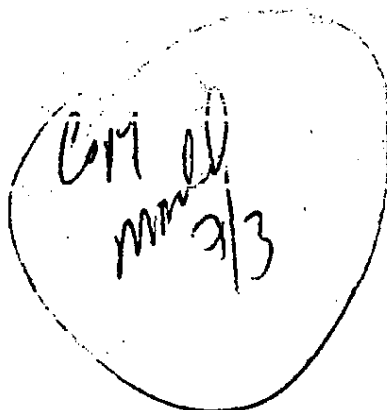
