The Shareholder reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto.

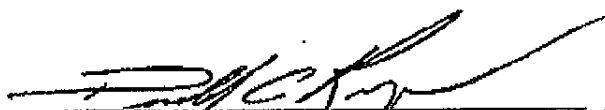
