## ARTICLES OF INCORPORATION

OF

AMERICLEAN SERVICES, INC.

THE UNDERSIGNED, acting as subscribers of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is
