**THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.**

**WITNESSETH**

**ARTICLE I  
NAME AND ADDRESS**

DURATION**

CAPITAL STOCK**

This Corporation is authorized to issue 1,000,000 shares of \$0.0001 par value common stock.

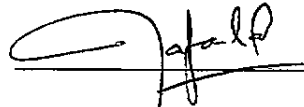
**ARTICLE IX

**ARTICLE X  
LIMITATION ON SHAREHOLDER SUITS**

Shareholders shall not have a cause of action against the Corporation's officers, directors or agents as a result of any action taken, or as a result of their failure to take any action, unless deprivation of such right is deemed a nullity because, in the specific case, deprivation of a right of action would be impermissibly in conflict with public policy of the State of Florida. The fact that this Article shall be inapplicable in certain circumstances shall not render it inapplicable in any other circumstances and the Courts of the State of Florida are hereby granted the specific authority to restructure this Article, on a case by case basis or generally, as required to most fully give legal effect to its intent.

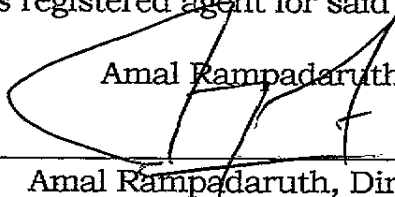
