AMENDMENT




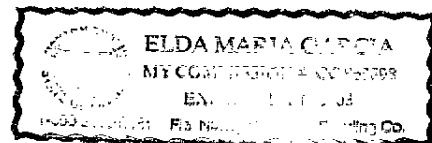
