

ARTICLES OF INCORPORATION
OF
INDIAN RIVER LABS, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopt the following Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is **INDIAN RIVER LABS, INC.**
