Dear Ms. Ashton,

I am in receipt of your letter dated August 2, 2006 regarding the dissolution of the above named corporation. Your letter references a rejection letter that was allegedly sent on March 2, 2006 with a 30 day window to correct the deficiency in the report.

My client, Oscar Medina of DOJC, Inc. never received this letter. The first time that the company heard anything about a problem with his filing was in July, 2006 and we replied with a letter detailing that the annual report was filed on February 15, 2006 and the check was cashed on February 27, 2006. A copy of the cancelled check was also forwarded with this letter.

First, I would like to say that cashing that check in legal terms represents acceptance of the annual report as sent in to your office.

Secondly, as mentioned earlier, my client never received this letter. He could not respond within 30 days to a letter that he never received. Additionally, he was gone for several weeks in April and July. As soon as he received a notice, he forwarded the letter to our office and we tried to resolve this matter.

We are requesting that you waive the reinstatement fees and keep DOJC, Inc as an active corporation.

The only error that Mr. Medina made was signing on the wrong line(line # 8) instead of line # 12. It was an honest and unintentional mistake. Why punish an honest businessman?

I am attaching a corrected copy of the annual report with his signature on the correct line. We are sorry for the confusion and respectfully request that you reinstate this corporation and waive the reinstatement fees.
