ARTICLE I - NAME

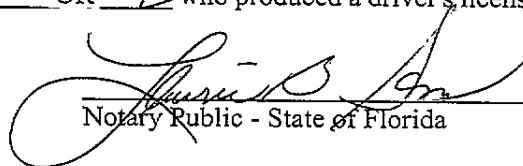
