ARTICLES OF INCORPORATION OF LCP CLEANERS, INC.

The undersigned incorporator hereby adopts these Articles of Incorporation for the formation of a corporation under Florida General Corporation Act.

ARTICLE I

NAME

The name of the corporation is LCP Cleaners, Inc.

ARTICLE II

DURATION _

The duration of the corporation shall be perpetual.

ARTICLE III

INCORPORATION
