

**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of this Corporation is **SENSIWEAR, INC.**

**ARTICLE II**

The existence of the Corporation shall be perpetual.

**ARTICLE III**

The principal place of business and mailing address of this corporation are 14135 N.E. 3<sup>rd</sup> Court, North Miami, Florida 33161.

**ARTICLE IV**

The maximum number of shares this corporation is authorized to issue is 500 of \$1.00 par value common stock. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

It is the further intention and purpose of the subscriber of these Articles of Incorporation that the stocks of this corporation be qualified and subscribed to and sold all in accordance with the provisions of Section 1244 of the Internal Revenue Code and it is contemplated that the stockholders and officers of this corporation shall adopt such resolutions as are appropriate in order to effectuate the treating of the stock of this corporation under Section 1244 of the Internal Revenue Code.

#### **ARTICLE VII**

The initial board of directors shall consist of two (2) members. This number may be increased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The name and address of the persons who will serve on the initial board of directors are as follows:
