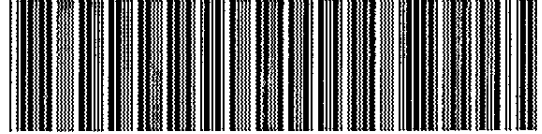

ARTICLES OF INCORPORATION

OF

DAVID T. PEREZ, P.A.

The undersigned incorporator, for the purpose of forming a professional service corporation under Section 621.05, Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of this Corporation (the "Corporation") shall be **David T. Perez, P.A.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be 7255 Bedlington Road, Miami Lakes, Florida 33014.

ARTICLE III: CAPITAL STOCK

The Corporation is authorized to issue 10,000 shares of Common Stock, having a par value of one (\$1.00) dollar per share.

ARTICLE IV: INITIAL REGISTERED AGENT AND ADDRESS

ARTICLE V: INCORPORATOR

ARTICLE VI: GENERAL PROVISIONS

The General Purposes for which the Corporation is initially organized are:

- (a) To render the following specific professional services (as defined in Section 621.03 of the Florida Professional Service Corporation Act) and none other, to wit: the personal services rendered by attorneys at law as provided by Chapter 454 of the Florida Statute or any successor statute providing therefore.
- (b) And in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida Business Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto, so far as such powers and privileges are consistent with, and not prohibited by, the Florida Professional Service Corporation Act.

ARTICLE VII: DIRECTORS

The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided by the Bylaws but shall never be less than one. The name and address of the initial director of the Corporation is: David T. Perez, Esquire, 7255 Bedlington Road, Miami Lakes, Florida 33014.

ARTICLE VIII: ESTABLISHMENT

The corporate existence of the Corporation shall commence upon the filing of these Articles of Incorporation.
