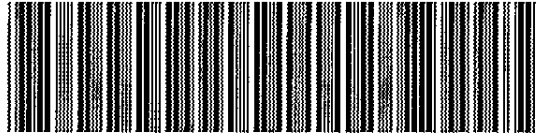

The name of this corporation shall be **E-Z DEAL II, INC.**

ARTICLE II

This corporation shall have its principal office at 3297-3299

ARTICLE III

The purpose of this corporation is to transact any and all
