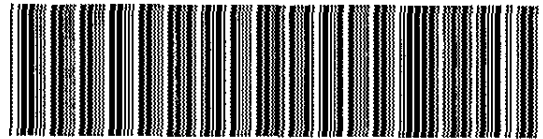

The name of the corporation is TOP TRANSPORT, INC. (the "Corporation").
