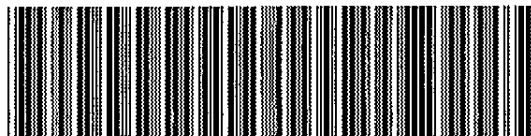

ARTICLE I
