#### ARTICLE I Name and Principal Office

The name of this corporation is LEWIS BAIT & TACKLE, INC. The principal place of business and mailing address of this corporation is 2827 Northwest Pine Avenue, Ocala, FL 34475.

#### ARTICLE II Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

## Purpose
