



ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation for the purpose hereinafter stated, under and pursuant to the laws of the State of Florida, does hereby declare as follows:

ARTICLE I

The name of the corporation shall be COOPER PLAZA MANAGEMENT CO., INC.

ARTICLE II BUSINESS AND PURPOSE

The nature of the business which may be transacted by the corporation is as follows:

This corporation may engage in any activity or business permitted under the laws of the State of Florida, and shall enjoy all the rights and privileges of a corporation granted by the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be One Million (1,000,000) shares of common stock, and shall be \$.01 par value per share. The capital stock may be paid for in property, labor or services at a just valuation, to be fixed by the incorporators or by the directors at a meeting called for such purpose, or at the organization meeting. Property, labor or services may be purchased or paid for with the capital stock at a just valuation of said

property, to be fixed by the directors of the corporation. Stock in other corporations or going businesses may be purchased by the corporation, in return for the issuance of its capital stock, and said purchases shall be on such basis and for such consideration as the issuance of so much of the capital stock as the directors of the company may decide.

ARTICLE IV PRE-EMPTIVE RIGHTS GRANTED

Each shareholder shall have pre-emptive rights only in the portion of shares being issued or sold equal to the proportion that the number of shares then held by the shareholder bears to the total number of shares of the same class then outstanding.

ARTICLE Y TERMS OF EXISTENCE

This corporation shall have a perpetual existence unless sooner dissolved according to law.

ARTICLE VI PRINCIPAL OFFICE

The principal office or place of business of the corporation shall be located at 1300 North Federal Highway, Suite 212, Boca Raton, FL 33432, with privilege of having its offices and branch offices at other places within or without the State of Florida

ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT

The initial Registered Agent of this corporation shall be Amy E. Schultz, a resident of Florida, and the initial Registered Office of the corporation shall be 1300 North Federal Highway, Suite 212, Boca Raton, FL 33432.

ARTICLE VIII BOARD OF DIRECTORS

The affairs of the corporation shall be conducted by a board of not less than one (1) and not more than three (3) directors.

ARTICLE IX INITIAL DIRECTORS

The name and address of the first Board of Directors, who, subject to the provisions of these Articles of Incorporation, shall hold office for the first year of the corporation's existence, or until their successors are elected and shall have qualified, are the following:

- The fact of such relationship or interest is disclosed or known to the Board Α. of Directors or committee which authorizes, approves or ratifies the contract or transaction by a vote or consent sufficient for the purpose, without counting the votes or consents of such interested directors; or
- В. The fact of such relationship or interest is disclosed or known to the shareholders entitled to vote, and they authorize, approve or ratify such contract or transaction by vote or written consent; or
- The contract or transaction is fair and reasonable as to the corporation at the time it is authorized by the Board, a committee, or the shareholders.

Common or interested directors may be counted in determining the presence of a quorum at a meeting of the Board of Directors as a committee thereof which authorizes, approves, or ratifies such contract or transaction.
