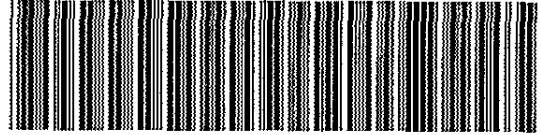

**Article I: Name**

The name of this Corporation is *The Chalaco Corporation*.

**Article II: Duration**

The Corporation shall have perpetual existence.

**Article III: Purpose**
