#### **ARTICLES OF INCORPORATION**

#### **GAIT SITE SERVICES, INC.**

The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes.

## ARTICLE I (Name of Corporation)

The name of the corporation is **Gait Site Services**, **Inc.** (the "Corporation").

## ARTICLE II (Corporate Existence)

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on October 23, 2002, 2002, and the Corporation shall have continuous and perpetual existence thereafter.

### ARTICLE III (General Purpose of Corporation)

The general purposes for which the Corporation is initially organized are as follows:
