ARTICLE I -NAME-

THE NAME OF THIS CORPORATION IS: CREATIVE KIDS LEARNING CENTER, INC

ARTICLE II -DURATION-

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE COMMENCING ON THE DATE OF EXECUTION AND ACKNOWLEDGEMENT OF THESE ARTICLES.

ARTICLE III -PURPOSE-
