1. Andrew J. Nettles Jr. is the Vice-President of NETTLES ENG ENTERPRISE, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on 19 September 2003.
