ARTICLES OF INCORPORATION OF TRAFFIC EDUCATION CENTER, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLEI

The name of the Corporation ("Corporation") is TRAFFIC EDUCATION CENTER, INC.

ARTICLE 11

The existence of the Corporation shall begin on October 25, 2002.

ARTICLE III

The street address of the principal office of the Corporation is 4487 Stirling Road, Fort Lauderdale, FL 33314.

ARTICLEIV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares.
