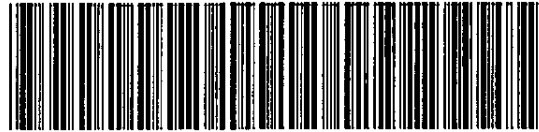

Name and Address**

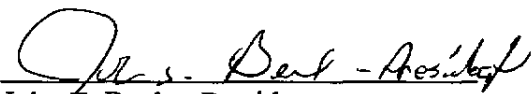
