

#### ARTICLES OF INCORPORATION

# INFONEUTIC, INC.

The undersigned, acting as incorporator of Infoneutic, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I

# NAME AND PRINCIPAL PLACE OF BUSINESS

EFFECTIVE DATE
