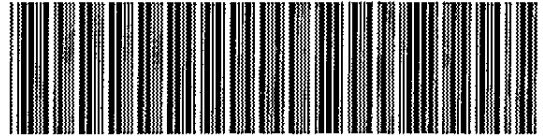

ARTICLE I.

The name of this corporation shall be NOTHING INTERNATIONAL, INC., whose address is 9035 Flynn Circle - #3, Boca Raton, Florida 33496.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE III.

CAPITAL STOCK

This Corporation is authorized to issue a maximum of 5,000 shares of stock. The shares of stock authorized shall be divided into two classes of common stock designated as voting and non-voting, each class having a par value of \$1.00 per share. The corporation shall indemnify all officers and directors, and former officers and directors, to the full extent permitted by law as the law now exists or may be amended hereafter.



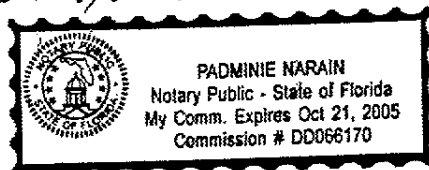
