

The undersigned, acting as incorporator of this corporation under the Florida General Corporation

Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

# ARTICLE I - NAME

The name of this corporation is: OPEN DOOR BOOKS, INC.

# ARTICLE II - ADDRESS
