## ARTICLES OF INCORPORATION OF SENTRY ENTERPRISES, INC.

THE UNDERSIGNED, acting as sole incorporator of SENTRY ENTERPRISES, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:
