

#### ARTICLES OF INCORPORATION

OF

#### JIMMY'S CAR STEREO, INC.

## ARTICLE I - NAME:

The name of this corporation is: JIMMY'S CAR STEREO, INC. hereinafter referred to as the "Corporation".

# ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Car Stereo Sales business and for the purpose of transacting any or all other lawful business not inconsistent with Laws of the State of Florida.

### ARTICLE IV - CAPITAL STOCK:
