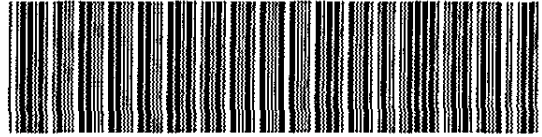





AMENDMENT**


