

ARTICLES OF INCORPORATION OF NATIONAL SALES TRAINING INSTITUTE, INC.

THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

<u>ARTICLE I - Name</u>

The name of the corporation shall be NATIONAL SALES TRAINING INSTITUTE, INC. (hereinafter referred to as "the corporation.").

ARTICLE II - Principal Office
