I represent Spa Royale, Inc. On or about September 11, 2003, my client mailed their 2003 Uniform Business Report ("UBR") and a check in the amount of \$550 to the Florida Department of State (the "Department") for the filing fees therewith. A copy of the cancelled check has been enclosed for your ready reference.

Subsequently, even though my client's check had been negotiated by the Department on September 18, 2003, they administratively dissolved my client's corporation. My client only found out about the dissolution by chance. Upon calling the Department on October 3, 2003 to inquire as to the reason for the dissolution in the face of a cancelled check, I spoke with Eula and she indicated that the corporation was dissolved because the UBR was "incomplete" in that some of the officer information was apparently lacking. To further complicate matters, the Department mailed notice to an address in Jonesville, Florida and therefore my client was unaware of any response or action on the part of the Department.
