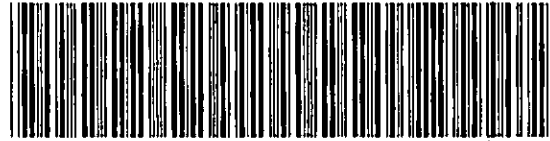

The name of this Corporation shall be:

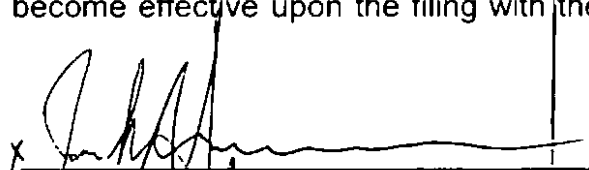

ARTICLE III - NATURE OF BUSINESS

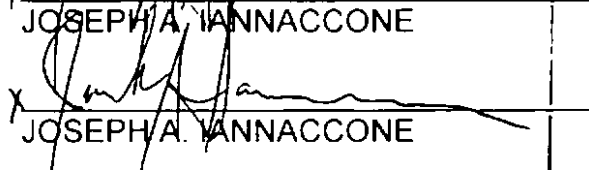
