

### ARTICLES OF INCORPORATION



OZDECZ4 AN 9:59 Pursuant to the provisions of F.S.A. Section 607.1006, corporation adopts the following articles of amendment to its incorporation.

FIRST: The name of the corporation is changed to RIVER LANDINGS REALTY,

INC.

The date of adoption of the amendment was December 11, 2002. SECOND:
