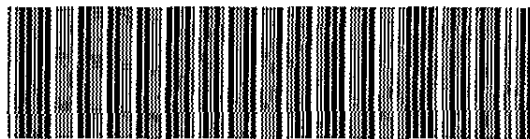

ARTICLE I

The name of the corporation is BURKEY RISK SERVICES, INC. STATE OF FLORIDA

ARTICLE II




