

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

FLORIDA BUSINESS FINANCE CORP., a Florida Corporation (Document No.: P02000115647)



Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is Florida Business Finance Corp. (document number P02000115647).
- 2. Article IV of the Articles of Incorporation of the corporation shall be amended in its entirety to read as follows:
