# ARTICLES OF INCORPORATION OF CARPETS AND MORE OF MIDDLEBURG, INC.

The undersigned hereby executed these Articles of Incorporation for the purpose of becoming a corporation under and by virtue of the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges of immunities of a corporation for profit.

#### ARTICLE I

The name of this corporation shall be: CARPETS AND MORE OF MIDDLEBURG, INC.

The general nature of the business to be transacted by this corporation is: flooring installation.

- (c) To manufacture, purchase, or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in trade in, deal in and with goods, wares, merchandise, real and personal property,, and services of every class, kind and description; except that it is not go conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
- (d) To conduct business in , have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses in the State of
